

## **Pacific and Southwest Regional Health Equity Council: New Priorities, Members, and Leaders Focus Efforts on Reducing Health Disparities**

The Pacific and Southwest Regional Health Equity Council (PSWRHEC), which recently held its Annual Review and Planning Session, announces its new membership and activities. **PSWRHEC is the Pacific and Southwest branch of the National Partnership for Action to End Health Disparities (NPA), the first national movement to target the elimination of health disparities and move the nation towards health equity.**

The NPA is a multi-sector community- and partnership-driven effort that is implemented at the regional and state levels by 10 Regional Health Equity Councils (RHECs). PSWRHEC represents Region IX, which encompasses Arizona, California, Hawaii, Nevada, American Samoa, Commonwealth of the Northern Mariana Islands, Federated States of Micronesia, Guam, Marshall Islands, and Republic of Palau.

PSWRHEC (also known as RHEC IX) is comprised of leaders from diverse backgrounds whose work serves as a catalyst for health equity; the 29 volunteer voting members – leaders who represent academia, research, health care, state and local government, civic and nonprofit organizations, and private industry – are assisted by *ad hoc* members and emerging health professionals. **The council's mission is to eliminate health and healthcare disparities and achieve the highest possible level of health for all communities through the education and mobilization of leaders, partners, policy makers, and community stakeholders.**

PSWRHEC's activities are coordinated by three co-chairs and are directed by six committees—Behavioral Health, Funding and Sustainability, Health and Health Care Disparities Textbook, Influencing Health Policies, Partnerships and Collaborations, and Pathways to Healthcare Careers—in the following **priority areas**:


- Plan and develop a **textbook on health and healthcare disparities/strategies for achieving health equity** for publication
- Provide broader **awareness of innovative healthcare professional training**
- **Disseminate information about access to quality health care and support patient education**

- Assess the state of behavioral health and **influence behavioral services and policies** to ensure equity
- Create an infrastructure enabling PSWRHEC to **receive funding from various sources**
- Plan and implement **community outreach and education programs** to reduce health disparities and promote health
